The meeting was called to order at 2:08 p.m.

Observers were identified and welcomed. Procedures to be used during the meeting and while voting on motions were outlined.

1. Indigenous Land Recognition

J. Dickinson provided an acknowledgement that the Mount is built on traditional, unceded Mi'kmaq territory and paid respect to the Indigenous peoples of the land on which Senate meets.

2. Approval of Agenda

Moved by S. Hale Wills, seconded by S. Trenholm, to approve the agenda as circulated. CARRIED.

3. Approval of Minutes

3.1. January 31, 2025

Moved by B. Russo, seconded by T. Yu, to approve the minutes of January 31, 2025, as circulated. CARRIED.

4. Business Arising from the Minutes

No business arising from the minutes was identified.

5. Administration Updates

5.1. President

J. Dickinson noted that she would be taking the full time allotted for Administration Updates and began by reporting on two key government updates:

Firstly, regarding bilateral agreements, J. Dickinson reported that universities have been asked for input and that MSVU made the following requests/recommendations:

- Enhanced access to affordable post-secondary education for Nova Scotian students, including increasing the Nova Scotia undergraduate bursary, capping tuition increases at 2%, expanding graduate student scholarships and increasing the portion of forgivable NS student loans
- A 5% increase in the University's operating grant
- Advocacy for regional labour market needs to be reflected in the IRCC Post-Graduate Work Permit exceptions list
- Yearly infrastructure grants to address deferred maintenance and accessibility projects

Secondly, J. Dickinson reported on the proposed omnibus act (Bill 12) and its potential impact across various areas of advanced education, including:

- Bestowing degree granting privileges to NSCC
- More government control over the composition and size of university boards
- Mandated "revitalization" plans for universities running year-over-year deficit budgets

Additionally, J. Dickinson provided updates on AAAPs (Aboriginal Academic Access to Post-Secondary) program funding, which is now guaranteed for three years; the resignation of Art Gallery Director, M. Colosimo; and the ongoing Black & Indigenous Speaker Series.

6. Question Period

Extensive discussion occurred on Bill 12, with Senators raising various opinions and questions while emphasizing the importance of collaboration between the Board of Governors and Senate. Topics included a new "University Board Governance Act" proposed to oversee all post-secondary institutions in Nova Scotia; concerns about the potential for conflict between the new act and our charter; the role of MPHEC and its composition; education of the public on the role of universities in society and the importance of university autonomy; suggestions for media training and public affairs involvement; efforts underway to expand partnerships with NSCC and other colleges, including those in other provinces; and a joint meeting of the Board and Senate. (D. Piccitto, J. Dickinson, G. Durepos, L. Francis, A. Benzaquén, A. Thurlow)

- D. Piccitto spoke about the MSVU EDIA Advisory Committee, highlighting that it is intended to meet four times per year, as per the Terms of Reference, and requested the committee be reactivated and report to Senate. I. Nault reported that a subcommittee has held multiple meetings to develop the EDIA Action Plan, which will be released soon. B. Russo expressed support for the whole EDIA committee to meet, noting that it has not convened as a whole in the past two years. She also raised concerns about EDIA programs and policies being targeted for cuts, citing examples at other universities. J. Dickinson reaffirmed the Mount's commitment to EDIA and stated that efforts are underway to explore ways to effectively present this commitment.
- C. Barker requested that, when staff retire, resign or move to other positions, formal communication be sent to the Mount community to ensure continuity of services.

 J. Dickinson clarified that the AVP of University Relations typically handles such communications and emphasized that once a candidate is hired, addressing this will be made a top priority.
- C. Barker inquired about the scheduling of formal discussions between faculty, students, and administrators regarding post job action and rebuilding relationships. J. Dickinson shared that the AVP of People & Culture has provided a draft plan on University wellness and culture, advising to contact C. Hattie for further details and offering to bring this update to the next Senate meeting.
- M. Gonick requested information on the course selection process for the AAAPs program, specifically regarding any decolonization efforts. C. Dawson explained that they consult with current students and staff at the Mi'kmaw Native Friendship Centre for course recommendations. She also mentioned that the Friendship Centre advocates for the inclusion of Indigenous instructors and the representation of specific courses in the program.

Minocha also reported on the community partners project aimed at connecting students with external organizations to foster community engagement

and reported on efforts to establish service-based learning opportunities at the Mount.

D. Hazelton announced the upcoming "Safe Rave" event, with all proceeds benefiting the organization "Wellness in Nova Scotia."

K. Schlief reported on the ongoing work to reconcile the SU's financial statements from the previous two years and the continued operation of SU services over the summer. K. Schlief encouraged committee chairs to contact the SU if student committee representatives are not attending meetings and provided an update on the upcoming SU elections, urging Senators to direct interested students to the SU.
