### Canada-France joint Funding Opportunity on Artificial Intelligence

Application deadline: **2024-10-15, at 5 p.m. (CET)**

AAPG are pleased to announce the upcoming launch of a joint call for Canada-France research proposals on artificial intelligence ([Generic Call for Proposals \(AAPG 2025\)](#)). This call will be led by the French National Research Agency (ANR), in collaboration with NSERC, SSHRC, CIHR, and IVADO, and will support collaborative multi- and inter-disciplinary research projects in the areas of generative AI and the safety of embedded AI.

As a first **mandatory** step, the French Scientific Coordinator will register their intention to submit a project to the ANR by **5pm CET on October 15<sup>th</sup>, 2024**, clearly identifying the Canadian Principal applicant and other members of the Canadian team. The full proposal will be submitted by the French Scientific Coordinator in **March 2025**. Canadian researchers involved in such proposals will have to submit a simplified application to NSERC at the same time.

Horizon Europe is the world's largest research and innovation funding program involving countries around the globe. As one of the most ambitious funding programs, it gives Canadian's access to even more opportunities to elevate their research and innovations through global partnerships. Horizon Europe is running from 2021-2027.

In November 2023, the Government of Canada closed substantive negotiations with the European Commission (EC) to increase collaboration under Horizon Europe. Now applications from Canadian researchers and innovators will be reviewed as fully-fledged



members of consortia in Horizon Europe Pillar 2 calls. While Canadians can participate in all Horizon Europe calls that are open to international partners, as an associated country, Canadians can access a broader range of research opportunities in Pillar 2.

### Government of Canada Research Security Sensitive Technology Research Areas of Concern (STRAC) FAQ Updates

The Government of Canada has just updated their [FAQs for the new policy on Sensitive Technology Research Areas of Concern \(STRAC\)](#). It includes more further clarity on co-publications, a new question on Third Party Organizations and further clarity on its application in relation to international students. Specifically, we were able to identify changes and additions to Q1, Q5, Q11, Q12, Q19, Q20, Q27, Q28 and Q29.

### Sensitive Technology Research and Affiliations of Concern (STRAC) Policy

In accordance with the [Sensitive Technology Research and Affiliations of Concern \(STRAC\) Policy](#), grant applications submitted by a university or affiliated research institution to the federal granting agencies and the Canada Foundation for Innovation involving research that aims to advance a [Sensitive Technology Research Area](#) will not be funded if any of the researchers involved in activities supported by the grant are currently affiliated with, or in receipt of funding or in-kind support, from a [Named Research Organization](#).

The federal granting agencies are implementing the STRAC Policy in a harmonized manner, to funding opportunities that launched as of May 1, 2024. Further guidance, including detailed procedures and a [list of funding opportunities](#) that will apply this Policy, have been published through the [Tri-Agency Guidance on the STRAC Policy](#) webpage.

Please consult the appropriate funding opportunity literature to determine whether the STRAC Policy applies and, where applicable, for any additional information on procedures to be followed.

### Resulting Changes for rolling intake funding opportunities, such as Alliance

As of May 1, 2024, new requirements apply to [all Alliance grant applications](#) aiming to advance a listed sensitive technology research area. Further information on these new

requirements, including [new responsibilities of researchers](#) and [responsibilities of institutions](#), are provided on the [Tri-Agency Guidance on the STRAC Policy webpage](#).

This includes, at the application phase, a requirement for researchers in named roles to complete the [Attestation for Research Aiming to Advance Sensitive Technology Research Areas Form](#).
