

Study Permit Extension and Co-op Work Permit application

Do not allow your study permit to expire for any reason. If your study permit expires before you can complete your studies, you must renew it at least a month before the expiry date. In order to apply for a co-op/ internship/practicum work permit you must be registered in a degree program that requires you to work

internship/practicum work permit you must be registered in a degree program that requires you to work for at least one term and will receive academic credit during this work term.

NOTE: that if your passport is expiring, you must apply for a new passport before applying for your study permit. Also, if you intend to work in Canada after you graduate, you will need a valid study permit when you apply for your Post-Graduation Work Permit.

1. Log in to your online immigration account using GCkey or Sign-in Partner

*If you are a new user, you will need to create your account through GCKey or Sign-in Partner. NOTE: Save your username and password. Consider taking a screenshot of all your security questions and answers to avoid getting locked out of your account. Once you are locked out of your account, you will never be able to access it ever again.

Enrolment Letter and Official Transcripts

For the enrolment letter, fill out the <u>Letter Request Form</u> and email it to <u>heather.standing@msvu.ca</u> and if she is on vacation, you can email it to <u>stephanie.hale@msvu.ca</u>. Do NOT go to the Registrar's Office counter and do NOT email <u>registration@msvu.ca</u> for this letter.

Note: When filling out the form, you must choose all of the following options:

- Confirmation of Enrolment Letter
- Visa Letter
- Extension of permit renewal
- and Other option box of Visa Letter, you should write 'Study Permit extension. PAL exempt'.

For Official Transcripts, you can go in-person to receive it right away OR you can fill out the <u>Transcript</u> <u>Request Form</u> and email it to <u>transcripts@msvu.ca</u>.



Medical Exam

IMPORTANT: in-Canada applications only

IRCC created a <u>temporary public policy</u> for immigration medical exams (IMEs) <u>until October 5, 2029 only</u>. If you completed an IME within the past 5 years, submit a copy of your previous medical exam.

To qualify for this temporary policy, you must meet **all** of these conditions:

- You applied, or are applying, for either permanent residence or temporary residence.
- You already live in Canada.
- You completed your previous IME in the last 5 years.
- Your previous IME indicated a low risk or no risk to public health or public safety.

NOTE: You need to submit your proof of medical exam performed by an IRCC approved physician if you plan to work in the fields of education, childcare, medical and healthcare services, nursing homes, taking care of elderly and other vulnerable people, hospital, and agriculture, etc. Click on this link to <u>view the list of IRCC</u> approved physicians by country to book your appointment if necessary.

7. Submit the application

Once your application has been successfully transmitted, you will receive a confirmation of application submission under "My Messages" or on your home account page.
