

International Education Centre Renewing your Temporary Resident Visa/Canadian Visa under a Study Permit status.

You may have to apply to renew your TRV if your will expires soon and you want to leave the country. If your passport and Study Permit are expiring, it is best that you renew both before applying for a TRV. Moreover, you must have a valid Study Permit before applying for your TRV. You can renew your TRV in Canada by applying online and sending your passport to Ottawa.

1. Log in to your online immigration account using GCkey or Sign-in Partner

*If you are a new user, you will need to create your account through GCKey or Sign-in Partner.

NOTE: Save your username and password. Consider taking a screenshot of all your security questions and answers to avoid getting locked out of your account. Once you are locked out of your account, you will never be able to access it ever again.



You have to Determine your eligibility to apply online for a Visitor/Study/Work Permit.



3. Complete online questionnaire

Do you want to work in one of the following jobs?	If you intend to work in certain jobs, you may be required to undergo a medical exam – these jobs include any work that brings you in close contact with others (working with children, in healthcare services or labs) or agricultural work. Do you want to submit an application for a family member?	It depends. You can add your family member(s) to your application if they also require a Temporary Resident Visa.
Are you giving someone access to your application?	No – if you are applying only for yourself. However, if you are applying for family members then you should choose: 'Yes, both appoint a representative and grant authorization to IRCC to release information to another person'.
There are fees associated with this application. Will you be paying your fees or are you fee exempt?	Yes, I will be paying my application fees.
Are you able to make a digital copy of your documents with a scanner or camera?	Yes
Will you pay your application fees online using a Visa, Mastercard, Visa/Mastercard debit?	Yes. If you don't have a credit card, you can purchase a prepaid visa.

INSTRUCTIONS: You need to download the Adobe Acrobat Reader software to your computer that runs Windows or Mac OS. Do not use a Chromebook, tablet, or phone.

Under <u>Application Form(s)</u>. Click on the document "Application to Change Conditions...". After clicking it, a new webpage will open up. Download the file and save the PDF file on your laptop. Go to the folder where you saved the file. Right click on the file and choose "Open with Adobe Acrobat" PDF Reader. Fill it out using a computer and not by hand/print.

Enrolment Letter and Official Transcripts

For the enrolment letter, fill out the <u>Letter Request Form</u> and email it to <u>heather.standing@msvu.ca</u> and if she is on vacation, you can email it to <u>stephanie.hale@msvu.ca</u>. Do NOT go to the Registrar's Office counter and do NOT email <u>registration@msvu.ca</u> for this letter.

Note: When filling out the form, you must choose **all** of the following options:

- Confirmation of Enrolment Letter
- Visa Letter
- Extension of permit renewal
- and Other option box of Visa Letter, you should write 'Study Permit extension. PAL exempt'.

For Official Transcripts, you can go in-person to receive it right away or you can fill out the <u>Transcript</u> <u>Request Form</u> and email it to <u>transcripts@msvu.ca</u>.

Medical Exam

IMPORTANT: in-Canada applications only

IRCC created a <u>temporary public policy</u> for immigration medical exams (IMEs) <u>until October 5</u>, 2029 only. If you completed an IME within the past 5 years, submit a copy of your previous medical exam.

To qualify for this temporary policy, you must meet **all** of these conditions:

- You applied, or are applying, for either permanent residence or temporary residence.
- You already live in Canada.
- You completed your previous IME in the last 5 years.
- Your previous IME indicated a low risk or no risk to public health or public safety.

NOTE: You need to submit your proof of medical exam performed by an IRCC approved physician if you plan to work in the fields of education, childcare, medical and healthcare services, nursing homes, taking care of elderly and other vulnerable people, hospital, and agriculture, etc. Click on this link to <u>view the list of IRCC approved physicians by country</u> to book your appointment if necessary.

6. Pay the application fee with a credit card or visa/mastercard debit





7. Submit the application.

Once your application has been successfully transmitted, you will receive a confirmation of application submission under "My Messages" or on your home account page.

8. Wait for a response from IRCC and mail your passport within 30 days of approval.

Once your application has been processed, IRCC will send you a letter under "My Messages" in your online account. Please **print the passport request letter** and mail it along with your passport

Go to a Canada Post Office and purchase <u>two prepaid</u> Xpresspost envelopes (1 big and 1 small) with tracking numbers.

In the bigger envelope, put in your passport, IRCC Letter Request for Passport, and the other smaller envelope you purchased. This smaller envelope will be used to return your passport with your new TRV to you.
