

# What documents should I prepare?





#### Pack these in your carry-on bag in an envelope.

- 1. Valid passport 6-months minimum
  - Temporary Resident Visa (TRV) visa sticker on your passport)
     OR
  - Electronic Travel Authorization (eTA)
- 2. Letter of Introduction/Study Permit letter of approval.
- 3. MSVU Letter of Acceptance
- 4. Confirmation of Enrolment Letter or other proof of course registration.
- 5. Proof of English proficiency if required (IELTS or TOEFL)
- 6. Valid medical exam IRCC approved physician (if applicable). **NOTE:** a medical exam is only valid for 12 months.



#### Pack these in your carry-on bag in an envelope.

- 7. Proof of funds to show that you have enough money to support yourself during your stay in Canada.
  - Official receipt of tuition payment
  - o GIC
  - Cash or traveler's cheque
  - Wire transfer receipt
  - Scholarships
  - Online banking app
- 8. Letters of reference or any other documents recommended by the visa office where you applied.

**NOTE:** you must have access to all the documents you submitted in your study permit application (electronic or printed copies).



# Temporary Resident Visa (TRV) or Canadian Visa

**IMPORTANT:** Do not travel to Canada unless this has been issued to you.

#### **EXCEPT** if you are:

- from a visa-exempt country (you will need an eTA) or
- be a US passport holder.



### Temporary Resident Visa SAMPLE



**NOTE:** this does not require a separate application. This is automatically granted when your Study Permit is approved. One approved, you need to send your passport to receive this sticker on your passport.



# Electronic Travel Authorization (eTA)

**IMPORTANT:** Do not travel to Canada unless this has been issued to you.

#### **EXCEPT** if you are:

- from a country that requires a TRV; or
- a US passport holder.

**NOTE:** This is automatically given if your study permit application is approved. You will only receive an email of approval - no sticker or notation on your passport.



#### What you need to complete the form and pay for your eTA

You will need:

• a valid **passport** from a <u>visa-exempt country</u>



As of April 26, 2022: Lawful permanent residents of the United States are exempt from the eTA requirement. Find out what documents you need to travel to Canada.

- a valid email address, AND
- one of the following acceptable methods of payment to pay the \$7 CAD fee (non-refundable):
  - o Visa®, Mastercard®, American Express®,
  - o a pre-paid Visa<sup>®</sup>, Mastercard<sup>®</sup> or American Express<sup>®</sup>,
  - Visa Debit, or Debit Mastercard,
  - UnionPay<sup>®</sup>, or
  - ∘ JCB Card<sup>®</sup>.

#### **▼** Overview of the eTA application process





### Study Permit

When you meet the CBSA officer, you will exchange your Letter of Introduction for your Study Permit. Then:

- Check ALL the details printed on your Study Permit;
- Make sure everything is correct;
- Make sure the document is printed clearly.
- Look for the work authorization and conditions.


If there is no work authorization you will need to do a Study Permit renewal or amendment from Halifax.

You WILL NOT be able to work until you receive the new document.

This can take a very long time.

### Co-op Work Permit

If your Letter of Introduction indicates WP on the 2<sup>nd</sup> page, **make** sure that a Study Permit AND a Co-op Work Permit are both issued.

If you forget this at the PoE, you will have to apply in Canada. Processing times for this process are long, so this may delay your program completion.

Co-op WP is required for work terms (co-op/practicum/internship) required in your program. For example:

- Tourism and Hospitality,
- Public Relations undergrad,
- Child and Youth Studies undergrad,
- MEd. Lifelong Learning, etc.

- ✓ Be friendly and listen carefully! Present any document you are asked for, when asked.

  - if you do not, this will be a HUGE problem!
- ✓ Make electronic copies and a photocopy of ALL your documents.
  - documents prior to your arrival
  - documents you receive upon arrival
